

Annex I, Lot 4 – Registration & Voting system

A) <u>Maximum estimated value:</u> 35.000 EUR HTVA (please note that lots will be awarded to the most economically advantageous tender according to the 'best price-quality ratio' award method)

B) Description and purpose of the lot

The subject of this call for tender is the provision of registration services and voting system in view of ALDE Party Campaign kick-off event, in Brussels, on 20-21 March 2024. We expect up to 650 participants.

C) Minimum requirements

These services and equipment required include, but are not limited to, the following:

Event registration online

Online platform/system with the following commands:

- Creation of different participant profiles.
- Collection of all the event communications that participants have also received by email.
- Possibility to have access to the payment page to finalize the registration at the event.
- Creation of an approver module: tailored access to the platform to certain participants (International Officers) to approve and allocate voting rights to their Delegation (formed by certain number of delegates).
- Creation of a "Superadmin" module: tailored access for certain people of the ALDE Party Secretariat to modify participants' profiles, creation of new profiles, validate categories, remove/allocate voting rights and dashboard control to modify information about the event if needed.
- Mobile friendly

Onsite services during the event

- Registration onsite
- Print name badge with (or without) barcode.
- Real-time attendance statistics
- Self registration booth
- Laptop(s) or desktop computer(s) with monitor and badges' printers
- Installation, configuration, training of hostesses. Two different setups/build up might be required, if the event is organised in two different venues (for the first and second day)
- Onsite assistance



Voting services

- Software for the voting sessions
- Delivering of the emails with voting credentials for all the registered delegates
- Software for online voting
- Onsite support for the voting procedures
- Onsite support for changing voting rights (allocated to the Delegations) if needed
- Mobile friendly
- Rapid system of votes' counting
